The meeting is chaired by Francesco De Lorenzo and in the presence of the Notary Catherine Gillardin as a witness only for the counting of the votes, hereafter "the Notary". The meeting started at 15.45

SCRUTINY OF THE VOTES

In line with the ECPC statute, and following the process outlined by the ECPC Guide to the Election document approved by the ECPC Board (Annex 1), ECPC sent a voting envelope (Annex 2) to each ECPC Full Member. ECPC presents the postal invoices as proof of having sent the envelopes (Annex 3). In each voting envelope, the Notary was indicated as the recipient of all the votes for the ECPC Elections 2016.

The Notary received 113 envelopes containing the votes (Annex 5). 110 of the envelopes have been sent within the deadline (11th May 2016).

ECPC presents a list of ECPC Members which notified they have not received the voting envelopes (Annex 6). ECPC Office re-submitted these Members a new voting form as soon as they notified ECPC. Unfortunately, it is not possible to consider the votes sent after the deadline, according to the ECPC statute and the ECPC Guide to the Election document approved by the ECPC Board (Annex 1).

The President informs that Vlad Voiculescu withdrew his candidature for the Board and Audit Committee, and provides written proof of the communications with the candidate (Annex 7). The President also informs that Sergio Canzanella withdrew his candidature for the Board, and provides written proof of the communication with the candidate (Annex 8). All the votes for Vlad Voiculescu and the votes for Sergio Canzanella (Board Member) will not be considered.

The Notary proceeds with the scrutiny, opening each envelope individually and records the outcome. All envelopes and postal receipts are collected and preserved for future notice (Annex 4). The table below summarises the vote outcome:
